

Template Letter of Medical Necessity for Highmark

Instructions: Information to be described in the following template letter of medical necessity aligns with categories found in the corresponding Summary of Medical Criteria for OCAs. If a patient does not fit a criterion, available existing literature for each case should be supplemented with this letter.

This is an example summary, and information should be provided to insurance companies at the discretion of the health care provider.

Highmark Pre-Authorization

I am writing this letter to request pre-authorization for **Jane Doe** to perform an osteochondral allograft transplantation surgery. This letter provides information regarding the patient's medical history, current condition, diagnosis, and treatment rationale to support the medical necessity for an osteochondral allograft. This submission also includes all medical records and clinical notes, as well as the supporting medical literature.

Jane Doe is a **skeletally mature 35-year-old female** with a BMI of **30** and **no history of cancer**, who was first presented to my care in **January 2019**. The patient described **progressive, unrelenting and debilitating pain** in the patient's **right knee** since **July 2018**, which has persisted for **over 6 months**. The patient is **an avid runner** and has a lesion associated with **repetitive trauma** to the **right knee**. The patient **did not respond to 4 months of non-surgical management and microfracture**. **DESCRIBE ALL PREVIOUS FAILED NON-SURGICAL AND SURGICAL TREATMENT.**

Summary of examination: defect description and joint health

On **February 12, 2019**, I performed a diagnostic **arthroscopy** to evaluate the status of **Jane Doe's** knee, which has been included with this prior authorization submission. A **large, focal, full thickness lesion (Outerbridge Grade III)** was found on the patient's **right lateral femoral condyle** with an estimated size of **4 cm²**. The defect is surrounded by **definite borders of normal hyaline cartilage**. The arthroscopy showed **no lesions on corresponding tibia or patella**. There were **no signs of osteoarthritis or steroid-induced cartilage or bone disease**. The **physical examination** showed **stable knee with intact ligaments, normal joint alignment, and joint space**.

Treatment Recommendations and Rationale

The patient is an ideal candidate for osteochondral allograft. (*Reason patient not a candidate for TKA and needs OCA*) The patient is **35** years old and is too young for a total knee replacement. This osteochondral allograft procedure may prevent the need for a future total knee replacement and provide the patient a higher quality of life and return to activity. (*Patient compliance*) I have had multiple visits with the patient, and the patient is **willing and able to comply in extensive period of non-weight bearing and supervised post-operative physical rehabilitation program**. (*Describe your experience and success rates in your practice*) In my practice, I have seen high success rates (**~85%**) with this procedure for patients with similar defects in the lateral condyle. This procedure is medically necessary and meets all the criteria outlined in the **Highmark** medical policy (**Policy S-185-007 or S-185-013**). Additionally, in the clinical community, osteochondral allografts are the gold standard for treating large chondral and osteochondral defects in the femoral condyle. Over a decade of literature and clinical studies support the efficacy of this procedure and high success rates (75-85%). (*Describe attachments*) Attached with this letter are a number of peer-reviewed clinical publications that demonstrate the excellent clinical outcomes of this procedure for treating large chondral/osteochondral defects of the femoral condyles. Also attached are my clinical notes, dictations, results of diagnostics tests (i.e. MRI, arthroscopy, x-ray), and patient history.
